Guidelines and procedures for registering.

1. <u>Club</u> membership provides insurance coverage for the gym, allows your Boxers to represent the club in shows & tournaments and have a voice & vote in Association business. The club representative must be a registered non-athlete. Applications to *CN Lopez*, 2455 Ocala Ave. San Jose, CA. 95122. Fee: <u>\$ 250</u>, payable to <u>Nor Cal USA Boxing</u>.

2. <u>Non-athlete</u> membership provides you with insurance and liability coverage. Allows you to participate as a coach and/ or official. Attendance at a certification clinic is mandatory every 24 months and background screening required every 24 months. Registrations will be done 'Online' at <u>www.usaboxing.org</u>. Click on <u>"Become a member of USA Boxing today"</u>; go to <u>"Online Registrations"</u>; go to <u>"New members"</u> or <u>"Renew your membership"</u>; follow the five steps to register. Fees are: <u>\$ 60</u> for USA Boxing, <u>\$ 10</u> for Nor Cal, <u>\$ 25</u> for background and a <u>\$ 3</u> transaction fee – Total <u>\$ 98</u> or <u>\$ 73</u> if no background needed.

One can option to register by mail. Fees are: <u>\$ 105</u> with background and <u>\$ 80</u> with no background needed. Applications and background screening information to *CN Lopez*, payable to <u>Nor Cal USA Boxing</u>.

3. <u>Athlete</u> membership provides the Boxer with medical & dental insurance and the privilege to participate in USA Boxing events. Registration will be done 'Online' at <u>www.usaboxing.org</u>. See above for procedures. Fee are: <u>\$ 40</u> for USA Boxing, <u>\$ 10</u> for Nor Cal and a <u>\$ 3</u> transaction fee- Total <u>\$ 53</u>. Copy of the receipt must be mailed to *Robert Fernandez*, 274 Ney St. San Francisco, CA 94112.

One can option to register by mail. Fees are <u>\$ 60.</u> New athletes need: USA Boxing application, physical exam by an Medical Doctor, copy of birth certificate and two

passport type photos OR if renewing: USA Boxing application, physical exam and passbook. All paperwork to *Robert Fernandez*, payable to <u>Nor Cal USA Boxing</u>.

4. <u>Sanctions</u> for shows or tournaments can be used as club fundraiser and to showcase your Boxers. Applicant for sanctions must be a registered non-athlete for the registered club applying for the sanction. Application and certificate of liability to Chief of Officials, *Robert Rodriguez* 2074 Hillside Dr. San Leandro, CA 94577. All sanction forms & monies must be submitted 30 days in advance. Fee: <u>\$400; \$550</u> for two days, <u>\$100</u> for each additional day; <u>\$550</u> for Private Shows or when the admission price is <u>\$25</u> or more, payable to <u>Nor Cal USA Boxing</u>.
